

## LOCKER APPLICATION/RENTAL AGREEMENT

LOCKERS ARE FOR USE BY AT&T EMPLOYEES OR CONTRACTORS FOR THE STORAGE OF BICYCLE ONLY. COMPLETE SECTION 1-4 & 12. RETURN TO BISHOP RANCH TRANSPORTATION CENTER

PLEASE NOTE THAT LOCKERS ARE ASSIGNED ON A FIRST COME – FIRST SERVED BASIS.

Notice of expiration will be mailed to the Renter approximately 2 weeks before the date. The Renter may renew the Agreement by filling out a new application form. The Renter shall inform AT&T Security immediately of change in address (925-867-5218).

6. The Renter may terminate this Agreement before the expiration date by notifying BRTC in writing or in person of intent to terminate.

7. Notwithstanding the provisions of Sections 5 and 6, *BRTC may at any time during this Agreement, terminate the Agreement for any cause* upon 30 days prior written notice or, at its sole discretion may refuse to renew this Agreement upon its expiration.

8. Upon termination of the Agreement, keys should be returned to BRTC. *Any deposits paid will be applied to changing of locks – no refund provided.* In the case of abandonment, BRTC will attempt to contact renter – after 30 days, BRTC may recover possession of the locker and dispose of any property remaining in the locker in accordance with the law. **No deposits required.**

9. The undersigned represents that he or she is an AT&T employee or contractor, using a bicycle to commute at least 3 days per week and that the locker will be used for the storage of a bicycle ONLY. The locker shall not be used in, or in connection with any activity prohibited by law.

10. **THIS AGREEMENT LIMITS OUR LIABILITY – READ IT CAREFULLY.**

11. The Agreement entitles the Renter to store 1 bicycle in the above designated locker for the time period indicated herein. **STORE BICYCLE PROPERTY AND LOCK LOCKER.** BRTC is not responsible for fire, theft, loss or damage to any article stored/left in the locker. Renter shall indemnify AT&T and its directors, officers, agents, representatives and employees from any liability of any nature arising out of Renter's use of the locker.

12. The undersigned waives any claim to the right to privacy and expressly consents to allow BRTC to conduct random audits – to open and inspect the locker and the contents hereof at any time without prior notice, to determine whether a health or safety hazard exists; or to determine whether any term of this Agreement is being violated.

THIS CONSTITUTES THE ENTIRE AGREEMENT AND EXECUTION OF IT CONSTITUTES ACKNOWLEDGEMENT BY THE RENTER THAT THE RENTER HAS READ AND AGREES TO THE FOREGOING. THE PERSON SIGNING THIS AGREEMENT MUST BE 18 YEARS OF AGE OR OLDER.
